- 1. Sessions are typically on Tuesdays from 9 am to 12 pm per our agreement with ReImagine Recreation (R&R) for the use of the United Wholesale Mortgage Sports Complex (UWMSC). Check the web site (Skymasters.org) for exceptions to these times or dates. Please arrive no earlier than 15 minutes prior to session start. No flying before 9 AM or after 12 PM session unless approved by the Event Director (ED).
- 2. All Pilots/Drivers and Spectators must sign and have on file a ReImagine Recreation "Release Form Liability Form" when entering the arena. AMA Youth pilots must have the waiver signed by a parent or legal guardian. Pilots/drivers must abide by the procedures and rules implemented by UWMSC and R&R for their health and safety and the Skymasters Indoor Flying/Driving Rules. These rules are subject to change.
- 3. All Pilots/Drivers must provide proof of a current AMA membership.
- 4. Pilots/Drivers not flying or driving on any given day MUST register as a spectator. That includes season pass pilots.
- 5. Aircraft can weigh no more than 1-1/2 pounds All Up Weight. Helicopters & multi-rotor copters are limited to 250 maximum size. All aircraft must be powered by no more than a single 3 cell (11.1 volt) 1000 mAh battery.
- 6. First Person View-FPV is limited to micro quadcopters powered by a single cell battery (Max 500 mAh).
- 7. It is recommended that pilots/drivers use 2.4GHz transmitters as no pin control or impound is provided. All transmitters must be FCC Certified.
- 8. UWMSC, ReImagine Recreation and Skymasters are not responsible for retrieving aircraft stuck or lodged anywhere in the facility. That includes the top of the Arena Storage Area/Restrooms. Do not fly above the bottom of the truss line. Pilots are responsible for any and all costs incurred for the retrieval of their aircraft.
- 9. Fly ONLY in an area designated for the type of aircraft and flying being performed (refer to diagram at the registration table):
 - General Sport flying is to be conducted in the center section of the arena with the Pilot's flight line located on the east side between the cones/flags marking the 3D and ultra/micro quad areas.
 - Only counter clockwise pattern flying is permitted in this area unless changed by the ED.
 - > 3D flying in the sport area is not permitted.
 - Please observe the No Pilot Areas (NPA) at each end of the flight line.
 - > Pilots must make every effort to take off and land with the directional flow of the pattern.
 - Helicopters & Multi-rotors:
 - > The northeast corner of the field is restricted to helicopters and quadcopters.
 - Fixed wing 3D flight is permitted at the south end of the field only.
 - Micro airplanes (max 2 cell batteries) can fly along the west side of the arena.

10. Pilot's flight guidelines:

- All takeoffs, landings and flights must stay 15 feet in front of established flight line, never behind it.
- Pilots must stand or sit directly behind the Flight Line when flying. (Not in the bleaches)
- It is the pilot's responsibility to fly in a safe and courteous manner, maintaining control of your aircraft at all times and respect the air space of fellow pilots.
- All flying must be done in the designated areas of the Field #1 for your type of aircraft. No flying/driving in any another area. No exceptions
- No combat flying or use of streamers, except as approved designated activity by the ED.
- Flying may be interrupted for announcements and demonstrations by the ED.

- AMA Safety Code, Skymasters Indoor Flying Rules, Skymasters Constitution and Bylaws must be followed.
- Pilots should call out "On/Off the Field" and be observant for oncoming planes while on the field.
- 11. Pilots/drivers not complying with the Indoor Rules may have their flying/driving privilege suspended by the ED at any time.
- 12. Should an accident or incident occur involving personal injury to a pilot/driver, a spectator and/or property damage to UWMSC in any way, an incident report must be filed by the Pilot/s with the AMA, forms can be obtained by calling (765) 287-1256 or e-mail claims@modelaircraft.org After hours (765) 749-9210) for serious injuries only. The Pilot/Driver must also notify the Indoor ED and ReImagine Recreation immediately.
- 13. At the request of UWMSC Management please Do Not Use any chairs or equipment with sharp ends in contact with turf area. Such devices must have rubber feet or curved tube to not damage turf.
- 14. When working on your aircraft/cars or equipment you must provide a suitable work surface (i.e. plastic sheet, cardboard, etc.) under your model so as to prevent any damage to turf, bleachers or floors.
- 15. Pilots/drivers are personally responsible for all injuries and or damages incurred while flying/driving and while charging batteries in in the arena. Be responsible, this is a privilege and it may be revoked at any time.
- 16. All batteries must be charged in a suitable fire retardant container. No batteries (charged or discharged) may be disposed of or left at the arena. Please clean your area and take any trash with you when you leave. Do not leave any aircraft or cars at the arena or you may incur a charge for disposal.

17. Drivers guidelines:

- Electric cars may be run in the northwest corner of Field #4 only. Cars must meet be approved by the ED with a maximum size of 1/10th scale, with soft tires. Batteries must in hard shell packing.
- Drivers must stand behind soccer field perimeter markings (flight line) and drive in a safe and courteously maintaining control at all times. Do not hit the walls.
- Rules regarding charging, discharging and storage of batteries in the arena are the same as for drivers as for pilots.
- Driver's direction of travel is counter-clockwise unless changed by the ED.
- Due to the extended run time for cars batteries drivers are requested to not dominate the road track.
- Drivers do not collide with the walls. No burning rubber permitted at any time.
- Drivers should call out "On/Off The Field" and look for oncoming cars before going on the field. All
 other drivers on the track should then slow or stop their cars if someone is on the race course to
 retrieve their car.
- 18. Only approved sponsors may sell merchandise during any sessions. Prior arrangements must be made with Skymasters and Relmagine Recreation before the sale of any merchandise.
- 19. These rules are subject to change. Skymasters reserves the right to refuse flight/driving privileges to anyone.

UWMSC Facility Rentals

Here are a few expectations and rules we have for you while you enjoy your time with Reimagine Rec at the UWMSC. We want to keep our facilities in pristine condition so others can enjoy it as well. We ask that you abide by the expectations listed, or a fine taken out of your deposit. UWMSC is not responsible for any personal items that may be damaged or lost while renting. UWMSC is not responsible for retrieving any ball that gets stuck or lodged in the facility.

- 1. Leave the facility better than you found it
 - a. Pick up all the trash.
 - b. If you moved something during your time, return it to its original place.
 - c. If there are any lost and found items, place them in the cages on the field or take them to the front desk. If there are items that shouldn't be left in the cage, bring them to the front desk.
- 2. Contact the Manager on duty if any of the following come up
 - a. Someone gets sick on the field, and or bleeds on the field.
 - b. There is an issue with any of the bathrooms.
 - c. A basketball hoop/ Volleyball net needs to be adjusted.
 - d. A triple deck bleacher needs to be moved.
 - e. Something is damaged or breaks while you are renting.
 - f. There is an emergency (water leak, injuries ect.)
 - q. Doors are locked that are supposed to be opened.
 - h. Fields need to be painted.
 - There is a spill on the sport courts.
- 3. Please respect the facility and DO NOT do any of the following
 - a. Open the bay doors.
 - b. Prop open or exit through the emergency exit doors, when it is not a state of emergency.
 - c. Drink anything besides water on the sport court.
 - d. Bring food on the fields/ sport courts.
 - e. Use spaces that you are not renting.
 - f. Use metal cleats or spikes.
- 4. UMWSC is a zero tolerance facility for the following items
 - a. Tobacco, smoking, nicotine.
 - b. Alcohol.
 - c. Drugs.
 - d. Pistachios, peanuts, sunflower seeds, or anything else with a shell.
 - e. Painting or taping lines.
 - f. Any defacing or intentional damage to the facility
